On 10-29-97, at approximately 0910 hrs., Ms. Paige Turner contacted me at the Jackson County Sheriff's Department.

Ms. Turner informed me that she knew a subject named Steve Elliott who worked at the Pyramid Pizza in the Westport area. Ms. Turner stated she has known this subject for approximately two (2) years.

According to Ms. Turner Elliott told her, that a person he knew had told him about a conversation this person had with Byron Case. This person was told by Case that they (Justin, Case, Anastasia and Kelly) were in the cemetery and they had a gun with them. Byron "secretly" loaded the gun and handed it to Justin. Justin pointed the gun at Anastasia and pulled the trigger not knowing that Case had put a bullet in the gun. Ms. Turner does not know whom the person is that gave this information to Steve.

Ms. Turner has told Steve he should call me or at the least the Tips hotline, but he has not. This being the reason she is providing me with the information so \vec{I} could contact Steve directly.

I asked Ms. Turner if she has talked to Byron and she said she saw Byron and Kelly at the Pyramid Pizza this last Sunday at approximately 1530 hrs.. At that time, Byron told Ms. Turner his version of the evening of 10-22-97.

Byron told Ms. Turner, they had picked up Anastasia at the Dairy Queen and she and Justin began arguing. The car was stopped at Truman Rd. and I-435 when Anastasia told Justin she was getting out of the car. Justin told her no, but Anastasia exited the car anyway, saying she was going to call her dad.

The three then went to Justin's condo and at 2100 or 2130, Kelly left. Byron stayed with Justin until 2200 or 2230

I asked Ms. Turner if she asked Case how Anastasia was killed and Ms. Turner said she did not because her little sister was with her. Ms. Turner stated she did not think it appropriate to talk about how she was killed with her sister listening.

Ms. Turner stated, Kelly did not say anything while Byron was telling the story.

Ms. Turner stated she has heard that a subject named "Braum" has been saying that Justin and Byron stayed at his house that night.

Ms. Turner stated Byron has always hated Anastasia, because Anastasia was always annoying him. Ms. Turner stated that "a long time ago" she used to be friends with Case. On one past occasion Ms. Turner "sorta mentioned" Anastasia's name in front of Byron and he told Ms. Turner he hated that "bitch". Ms. Turner believes Byron Case has a "big part" in this (Anastasia's death).

According to Ms. Turner that prior to this last Sunday, she had not really talked to any of the three "for a long time".

When asked why, Ms. Turner stated she was "angry" at Anastasia. Ms. Turner said that near the end of school last year she had a study hall with Anastasia and Anastasia was talking about Byron Case because Anastasia "really liked Byron" and she was going on about how great he was. Ms. Turner then told Anastasia Byron was a "asshole". Anastasia asked her why she thought that and Ms. Turner told her that "Byron fucked around with my head, he played with my emotions". Anastasia told Ms. Turner "everyone likes to fuck around with you Paige". This was why she was angry with Anastasia and did not talk to her all summer.

Ms. Turner stated she saw Anastasia with Justin two or three times during the summer, but she did not speak to her.

Ms. Turner stated when the three (Anastasia, Justin and Byron) became a group, she (Turner) totally separated from them.

Ms. Turner stated she saw Anastasia "a couple of weeks ago" and Anastasia asked her why she never called her. Ms. Turner told her she didn't know where she was. Anastasia told her she was "back and forth" between Justin and her parents. Ms. Turner stated she "ignored" Anastasia and Anastasia left. Ms. Turner stated this was the last time she saw Anastasia.

Ms. Turner stated she had heard that Justin and Byron were lovers at one time, but she had no details of the relationship.

When asked, Ms. Turner said she knew nothing about a death pact between the foursome.

I asked Ms. Turner if she knew anyone that was knowledgeable of the "Goth" activities and she said she knew several people that were

into the "Goth", but she was not. Ms. Turner stated if she found someone that would speak to me about this subject, she would call me.

I asked Ms. Turner that if she heard anything about Anastasia's death to contact me and if I was not available then she should ask for Sgt. Ron Kellogg.
